## Ex-PM makes first Parli appearance since quitting

Colombo: Sri Lanka's former strongman Mahinda Rajapaksa on Wednesday made his first appearance in Parliament since he was forced to resign as PM and take shelter in a navy camp amidst violent protests against the economic crisis largely blamed on the Rajapaksas. His son and former minister Namal Rajapaksa also attended the session. Mahinda, 76, who served as PM thrice, saw his residence set on fire last week.

## Campaigning Oz PM tackles child during soccer game

SYDNEY

POLITICIANS are meant to kiss babies, not crash into children. But on the campaign trail on Wednesday, Australian PM Scott Morrison barreled into a young boy during a friendly kickaround, eliciting a chorus of "ooohs" and "aaaws".

Morrison was playing five-a-side soccer in Tasmania, where he is trawling for votes ahead of Saturday's election. At first, Morrison sauntered around the field aimlessly. But then, the 54-year-old stepped it up a gear, hunting down a cross-field pass that threatened the opposition's pop-up mini-goal.

Morrison, who recently described himself as 'a bit of a bulldozer', lowered his head and torso like a veteran sprinter and propelled himself forward to intercept the pass. Unfortunately, a small boy was in the way. Morrison's left shoulder drove straight into the child's face, sending both tumbling to the artificial turf.

Realising what he had done, Morrison threw his arms around the kid in a hug and lifted him off the ground, as a coach sprinted across for an impromptu Head Injury Assessment and lensmen switched to rapid-fire. AP
